This inspection is being performed for the exclusive use and benefit of the Client, and the Inspection, including the written Report, is not to be transferred to, utilized or relied upon by any other person or entity without prior written permission of the Company.

1. INSPECTION

The Company agrees to perform a limited visual Inspection of the systems and components included in the Inspection as they exist at the time of the Inspection and for which the Client agrees to pay a fee. The Inspection will be performed in accordance with the Standards of practice of the North Carolina Home Inspector Licensure Board and is limited by the limitations, exceptions and exclusions so stated in the Standards of practice and this Agreement. 2. LIMITATIONS, EXCEPTIONS AND EXCLUSIONS

The Inspection only includes those systems and components expressly and specifically identified in the Inspection Report. The Inspection limitations, exceptions and exclusions in the Standards of Practice are incorporated herein. In addition, any area which is not exposed to view, is concealed, is inaccessible because of soil, walls, floors, carpets, ceilings, furnishings or any other fashion is excluded. The Inspection does not include any destructive testing or dismantling. The following systems and components are areas are among those not included in the Inspection or Inspection Report:

- * Latent or concealed defects, compliance with code or zoning ordinances or permit research or system or component recalls.
- * Geological, soil, wave action or hydrological stability, survey, engineering issues, analysis or testing.
- * Termites or other wood destroying insects or organisms, rodents or other pests, dry-rot fungus; or damage from or relating to the proceeding.
